



Privacy Policy

By accepting this Privacy Policy, the user - in accordance with Act. No. 101/2000 Coll., on Personal Data Protection, as amended (the "Data Protection Act") - agrees with the collecting and processing of his/her personal data provided via means of this website by HighSky Brokers, a. s. (the "company") for promotional, advertisement and marketing purposes and for purposes of organizing seminars, workshops and other educational activities of the company. Moreover, the user declares that he/has have acknowledged the information that the administrator of personal data is obliged to provide the subject of data under the provisions of Section 11 of the Data Protection Act.

Personal data collected shall be processed by the company, its employees and cooperating parties automatically and/or manually. Nothing stated above precludes the subject of the data from appealing to the Office directly. Moreover it is the right of the subject of the data to be informed in respect to a blockage, correction, amendment or destruction of their personal data.
